# The Christian and the Death Penalty (Part 2)

What we established from the Bible in the article last week was that God instituted in the Patriarchal law to take a life would require the life of the person taking the life (Gen. 9:6). Under the Law of Moses, the Jews were commanded by God to execute those who took innocent life (Numbers 35:30) The Law allowed a remedy for those slain by accident rather than murder. (Numbers 35:9-29)

To protect against someone being executed for murder that was innocent, God instituted safeguards. Read Deut. 17:6-17, "Whoever is deserving of death shall be put to death on the testimony of two or three witnesses; he shall not be put to death on the testimony of one witness. 7 The hands of the witnesses shall be the first against him to put him to death, and afterward the hands of all the people. So you shall put away the evil from among you." Without the testimony of two or three witnesses someone could not be executed. Also note that the witnesses were the ones who began the execution.

To further protect the innocent person, laws were given for false witnesses. Read Deut. 19:15-21 "One witness shall not rise against a man concerning any iniquity or any sin that he commits; by the mouth of two or three witnesses the matter shall be established. 16 If a false witness rises against any man to testify against him of wrongdoing, 17 then both men in the controversy shall stand before the LORD, before the priests and the judges who serve in those days. 18 And the judges shall make careful inquiry, and indeed, if the witness is a false witness, who has testified falsely against his brother, 19 then you shall do to him as he thought to have done to his brother; so you shall put away the evil from among you. 20 And those who remain shall hear and fear, and hereafter they shall not again commit such evil among you. 21 Your eye shall not pity: life shall be for life..." So, if I accused someone of murder and it was found that I lied or was mistaken, MY life would be taken. Would that not be a good safeguard for our laws today?

We are told by Paul in Romans 13:1-2 "Let every soul be subject to the governing authorities... 2 Therefore whoever resists the authority resists the ordinance of God, and those who resist will bring judgment on themselves." As long as the death penalty is part of the laws of the land, in no way do they contradict anything in the Bible and a Christian cannot resist the government and this law on a Biblical basis. Should I advocate and support a fair and just application of capital punishment? Absolutely! If our current laws were changed to exclude capital punishment would that violate the Bible? No. Can a Christian oppose the death penalty until our laws are such that the innocent are never executed for something they did not do? Yes. Any punishment must always be justice rendered, NEVER revenge! (Rom. 12:19: Heb. 10:30)
